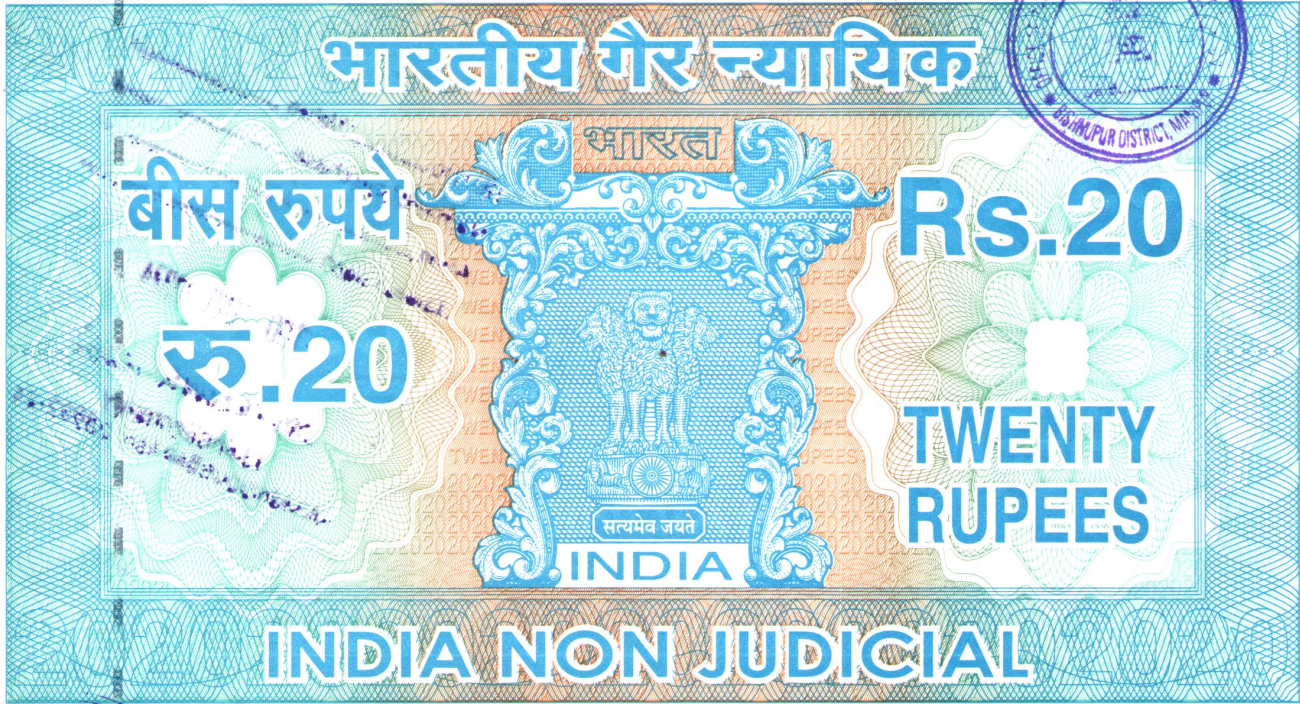

Moirang, P.S. Phougakchao Ikhai, Manipur, presently taking shelter at Khoyathong Relief Camp, Imphal, Manipur, do hereby solemnly affirm and state on oath as follows:

1. That, since the ethnic clash erupted between Kuki community and Meitei community on 03/05/2023 and a powerful IED bomb blast at Kwakta Bridge which is connect in between the Kwakta and Phougakchao Ikhai on 22/07/2023 at 7.30 pm, I along with my family and other people of Meitei community fled the area for our lives leaving behind everything. This is true to the best of my knowledge.
3. That, due to explosion all the valuable things of my house whole properties were fully damaged/destroyed. This is true to the best of my knowledge.
4. That, I could not report the matter on time and lodge FIR due to tense situation at Relief Camp and staying outside Manipur at a relative family at Guwahati. This is true to the best of my knowledge.

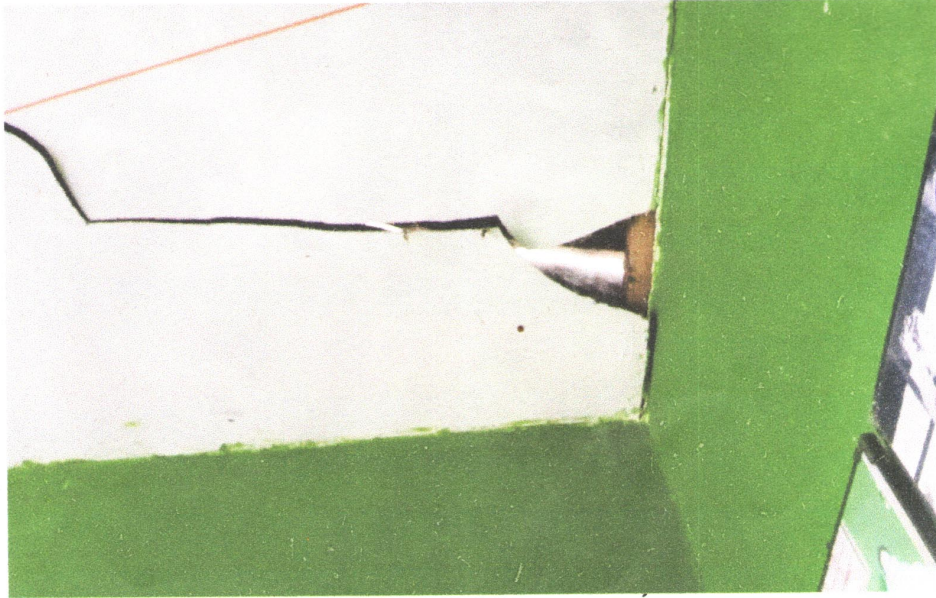

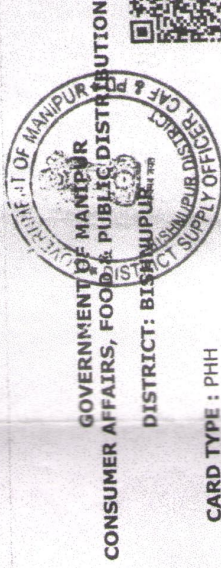
