Sir,

With due respect, I the undersigned namely Shri Longjam Devdas Singh S/o Longjam Chaoba Singh aged about 39 yrs, resident of Torbung beg to state that on 3<sup>rd</sup> May 2023 at about 6:00 pm some unknown armed persons belonging to Kuki Community started attacking us. Then they started destroying and burning house resulting all the properties were burned/destroyed/damaged/stolen before burning.

We were rescued by Armed Security personnel and provided a safe shelter. Later on, we have been evacuated to Moirang under armed escort. Hence, I and my family were here and there for survival due to unbearable panic feelings. Now, I am residing at one of relatives at Naranseina.

Hence, due to lack of knowledge I was not able to report regarding this matter to the Police on time.

In the facts and circumstances, it is therefore respectfully requested to take up an FIR against them in the interest of justice.
