3. That, from a reliable source, I came to know that, the valuable things from my rented canteen were looted by the unknown Kuki Armed Miscreants.

4. That, I could not report the matter on time and lodge FIR due to tense situation at Relief Camp. This is true to the best of my knowledge.

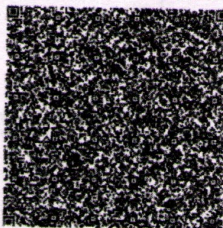

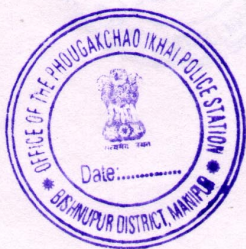

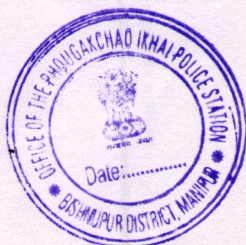
