SP(Ops)/TBL and under the overall supervision of Shri Rakesh Balwal, Sr. SP/TBL have rushed to the spot immediately and launched a massive operation at 04:30 a.m. On searching and found the undernoted articles i.e. (1) 1 (one) No. of 9mm Pistol along with magazine bearing registration No. 15065731, (2) 1 (one) no. of 36 HE Hand Grenade, (3) 10 (Ten) Nos. of 9 mm live rounds, (4) 1 (One) No. of Smoke Grenade from the spot i.e along NH-102 of Waithou inside the culvert at 5:07 a.m. and seized at 05:15 a.m. The massive searched Operation was conducted from 04:30 am to 06:30 am, on the same day.
