On receipt of the information, Special Operation Group (SOG) Thoubal District Police along with a column of 33 AR led by Inspt. K. Nitarnanjan Singh, OC/CDO-TBL under the command of Shri. H. Devendra Singh, Addl. SP(Ops)/TBL and under the overall supervision of Shri Rakesh Balwal, Sr. SP/TBL rushed to the spot immediately and launched a massive operation at 04:30 a.m. On searching the undernoted articles i.e. (1) 1 (one) No. of SMG Carbine along with magazine bearing No. 15506147, (2) 1 (one) No. of SBBL bearing No. 1537, (3) 1


