I, Shri Karnawaljit Thounaojam, working as Inspector Posts, Second Sub-Division, Manipur Postal Division, have been directed by the Superintendent of Post Office, Manipur Division, Imphal-795001 vide office letter no B-2/Md Riayajuddin(10185687) dated 18/07/2024(Copy enclosed) to register an FIR in the above case. Shri Md Riayajuddin, working as SPM (Sub Postmaster), Wangjing SO from the period 25/11/2020 to 05/07/2024 after applying leave without sanction/information has left the office misappropriating government money amounting to Rs 40, 74,138.98/-(Rupees Forty lakh seventy four thousand one hundred thirty eight and paise ninety eight) without handing over the cash to the new incumbent.
