11. First Information contents:

Today i.e. 09/09/2024 at around 1130 hrs, a large numbers of students of Thoubal District of different institutions including unknown youths carried out marching a rally along NH 102 towards the DC Office, Thoubal. On approaching at DC Office, Thoubal, they stormed the main gate of the DC Office, Thoubal. The police teams guarding at the DC Office, Thoubal main gate directed to disperse themselves but the unruly mob paid no heed to the instruction and the mob become more and more violent and started pelting stones towards the police team. Minimum forces were used in order to control the unruly mob, where some tear smoke munitions and stun grenades were fired. Some students were injured as a result of tussle in between them. In the incident, GI sheets, windows and other office materials of the DC Office, Thoubal were damaged.

Hence, a Suo Moto case under FIR No. 0095/TBL-PS/2024 dated 09/09/2024 of Thoubal Police Station, U/s 191(2)/132/125(1)/324(1) of the BNS, 2023 & section 3 of the PDPP Act, 1984 has been registered for investigation.
