11. First Information contents:

Today i.e. 09/09/2024 at around 1400 hrs, a large numbers of unknown youths including students of Thoubal District by holding deadly weapons approached from the both sides of NH 102 towards the gate of the District Police Headquarter, Thoubal with an intention to snatch arms and ammunitions. Police personnel of District Police, Thoubal as well as CAPF were deployed to counter the situation. Suddenly, the mob turned unruly and stormed towards the gate of the District Police Headquarter, Thoubal and started pelting stones. The police team directed the unruly mob to disperse by giving due warning. The mob started firing live rounds intermittently from different direction against the security personnel. Minimum force was used in order to control the unruly mob, where some tear smoke munition and stun grenade were fired. During the incident, one police personnel was hit by a live bullet on his left thigh and another police personnel was hit by an unknown projectile on his face. Immediately, they were

evacuated to Raj Medicity, Imphal for giving medical treatment using an Ambulance of District Hospital, Thoubal. As the situation was uncontrollable and volatile some live rounds were fired by the District Police in safe direction to deter the crowd. The enraged crowd attacked one Maruti Alto car white in colour bearing registration No. not known and was set ablaze beyond repair which was parked outside the District Court Complex, Thoubal. Reportedly, the Ambulance bearing registration No. MN01BA0340 belonging to The District Hospital, Thoubal which was used to evacuate the injured police personnel has also been badly damaged by the mob using stones, sticks etc. and the driver of the Ambulance was also injured.

Hence, a Suo Moto case under FIR No. 0096/TBL-PS/2024 dated 09/09/2024 of Thoubal Police Station, U/s 191(2)/191(3)/132/118(1)/109(1)/326(f)/324(1) of the BNS, 2023, 25(1-B) Arms Act and section 3 of the PDPP Act, 1984 has been registered for investigation.
