Sir.

I have the honour to report that on 06/07/2024 at around 11.30 am my daughter namely Akham Alice (14 Yrs) was kidnapped by 6 unknown persons from old assembly road, Imphal. My daughter told me that her hands and legs are tied by ropes and tape the mouth. They put my daughter in a car(red colour) and drove towards an unknown location. The exact details of the vehicle was not known but Jeep is written on back side and the vehicle number is also unknown. They released my daughter after some time at an undisclosed location. I could not report in time as my daughter hides the incident due to fear of them.

It is therefore requested to take necessary action as per law.
