

12. First Information contents:

MAL WESL Received an extract copy of the order dated 17th May, 2024 passed by CJM/IW vide Cril. Misc. (Investigation) Case No. 07 of 2024, filed by the Petitioner namely Smt. Sarungbam Pritam, aged about 53 years, W/o S. Jiten Meitei of Chingamathak Pishum Leirak, Imphal West District, Manipur and represented by her Ld. Counsel submitted that the petitioner is the wife of Sarungbam Jiten Meitei, who is a member as well as an Assistant General Secretary of All Manipur Football Association (AMFA) having its temporary office at Khuman Lampak Lamlong Thongkhong, Artificial Turf Ground, Ld. Counsel further submitted that on 01/04/2024, the present accused namely, Toijam Bihanta (48) Prop. of M/S Sintha Enterprises, S/o T. Rajendro Singh of Moirang Santhong Awang Leikai, Bishnupur District, Manipur a/p Laipham Khunou Makha Leikai, IE came to the temporary office of AMFA at Khuman Lampak, Lamlong Thongkhong, Artificial Turf Ground for taking his due amount of money from the office which was payable by the Office for hiring of chairs and other articles by the AMFA from the accused in c/w the performance of a tournament namely, "Santosh Trophy" at Imphal in 2023. Further submitted that on the day the accused became very angry as the payment dues were not made by the office. In that, husband of the petitioner tried to pacify the accused but he suddenly pulled Sarungbam Jiten Meitei and attempted to kill him by strangulating and throttling his neck by his hand, as a result, Sarungbam Jiten Meitei had suffered suffocation. The incident had happened in the presence of Thangjam Boyai Singh of Lalambung Takhellambam Leikai, Sanabam James Singh of Yairipok and Luwangshangbam London Singh of Sekta Makha Leikai and others. Further submitted that Sarungbam Jiten Meitei (husband of the petitioner) tried to push back the accused Bihanta and some other person also tried to drag out the accused Bihanta. However, the accused was dashed against the pointed border of the table and fallen down on the ground due to the pushing and dragging out by other members of the AMFA and Sarungbam Jiten Meitei (husband of the petitioner). In that, the accused got minor injuries on his body. Accordingly, the petitioner has lodged a report with the OC/Imphal-PS as well as to the S.P., Imphal West on 06/04/2024 and on 07/04/2024 respectively against the accused person for intentionally attempting to kill her husband by strangulation/ throttling his neck at the office of AMFA, Khuman Lamphal, Lamlong Thongkhong Artificial Turf Ground, Imphal West, Manipur but no action was taken.
