One complainant namely ~~Jamkhotin~~ Jamkhotin mang Haokip S/o Late Khaikholam Haokip of Canaan Veng North AOC, Imphal East District, Manipur reported that, He left his house last year i.e. 2023 on 5th May which is located at Canaan veng North A.O.C Imphal East due to the sudden crisis starting from May 3rd 2023 and could not take out his belongings fearing the situation. In the 2nd week of August 2024, he came across in some social Media platform that his house was damaged and his properties was looted by unknown miscreants suspected to be from the Meitei Community FIR was not done thinking his house and properties was intact/safe before seeing in social Media. To enquire he send a close friend and it came to his knowledge and confirmed that his house was damaged and his properties were looted and now occupied by some unknown persons of Meitei Community. The List of the properties looted/occupied are as given below:- 1. RCC Building -Rs. 20,00,000/- (Tewnty Lakhs approx) 2. Furnitures -Rs. 2,00,000/- (Two Lakhs Approx) 3. 6 Nos. of Almirah- Rs. 2,40,000/- (Two Lakhs Forty Thousand approx.) 4. Other Valuable Household Items -- Rs.10,00,000/- (Ten Lakhs Approx) 5. Misc. - Rs. 5,00,000/- (Five Lakhs approx) The approximate total value of properties damaged/looted is around 40 lakhs (Including my Pucca building that was damaged)


