As per endorsement, I have conducted an enquiry in c/w a written report lodged by one Thokchom Kishan Meitei 37yrs S/o (L) Th. Yaima Singh of Palace Compound, Thangapat Mapal, Imphal East District, Manipur where he stated that one individual namely Longjam Nelson Singh, aged about 30 years, S/o L Noren Singh of Keishamthong Longjam Leirak, Imphal West District, Manipur have taken a sum amount of 1,20,000/- (one lakh twenty thousand) on Jan.,2022 on account of buying a mobile phone from Dubai. But he has received neither the Mobile nor the Money till date. He made several attempts visiting his house regarding the return of the said amount, but all in vain. It refers to GD Entry No. 17/IPS/2024 dated 02/01/2024. During the course of inquiry several police summons have been served to the individual namely Longjam Nelson Singh but he never turns up at the Police Station. On further inquiry it is found that he impersonate as an IB (Intelligence Bureau) officer by showing a fake ID card of IB(Intelligence Bureau) and collected huge money from different girls of Imphal area.
