Today i.e. 7th Sept, 2024 at @ 2.30 PM, found a derogatory, alarming, threatening and abusive voice message which went viral in social media. The viral voice massage reproduced as follows:-"The war is happening right now, regardless of our position, makes it clear that sitting Dharna or forming Human Chain will not be enough. Therefore, all the Meira Paibis from different parts of Manipur should co-operate and contact each other and make a collective decision to fix a day to visit their respective MLA's house and threaten them by either breaking or burning their houses. This is not the time to consider the benefits or favours we received as a members or workers of BJP or Congress because if we support them at this time, day by day our Meitei people will die. So, the only option is, all the Meira Paibis of different places in Manipur should co-operate and contact each other and make decision and fix a date to go to their respective MLA's house and threaten them by either breaking or burning their houses."

The alarming and threatening viral voice message at this juncture of crisis in Manipur provokes the general public, causes fear and alarm to the general public, and induce any person to commit any offence against the public tranquillity and incites any class of community promoting enmity, hatred or ill-will between classes on the ground of religion caste or community.

Hence, a suo-mottu case under FIR No. 461(06)2024 IPS U/s 351(2)/196(1)(a)(b)/353(1)(b)(c)(2)/61(2) BNS has been registered for investigation.
