12. First Information contents:

Today i.e. 08/09/2024 at around 09.00 PM, a large number of irate citizens took out a rally along Tiddim road towards Keishampat Junction, Imphal decrying the inaction of both the state and central governments in reining in the escalating violent attacks by Kuki terrorists upon the civilian population. The protestors took out protest demonstrations in the middle of the road at Keishampat Junction, Imphal stopping traffic movement along the road. Immediately, a police team comprising of IGP/Zone-I, SP-IW, OC/Imphal-PS and other senior officers along with CRPF personnel rushed to the area where the protestors were asked to disperse from the place and not to cross beyond the Keishampat Traffic Junction, Imphal. The protestors were huge in numbers nearly about 1000 individuals comprising of many youths and women folks (Meira Paibis). They were convinced not to stage the unlawful assembly where the protestors blocked the Tiddim road at Keishampat Junction, Imphal by burning tyres. The protestors also vandalized the iron railing of road meridian at Keishampat Tiddim road and used the iron railings to block the road. The situation became worse and the mob was out of control and the mob started pelting stones by using catapults against the security forces. The irate mob also vandalised a police picket built near Keishampat Bridge. They also vandalized one CCTV camera post tower and other government properties installed at Keishampat. Ultimately, the security forces resorted to the use of non-lethal weapon like Tear Smoke Shell (long & short range) to disperse the mob with the permission concerned Magistrate. Some of the security forces received minor injuries.

Hence, a suo-motu case under FIR No. 462(9)2024 IPS U/s 191(2)/191(3)/223/132/118(2)/324(4)/3(5) BNS & Sec 3 of PDPP Act has been registered against the members of the unruly mob for investigation.


