Subject: Complaint

Sir.

With reference to a missing report lodged by the undersigned at Imphal Police Station on 30/08/2024 in r/o my wife namely Angomjambam Nirupam Devi I would like to lay the following few lines for your kind information and structure necessary action.

That, my wife has been found to have been kidnapped and abducted by Gunindro Moirangthem s/o Moiranthem Thanil Singh of Keishamthong Hodam Leirak as she was detected and caught on 08/09/2024 at around 03:30 pm along with the same person mentioned above at Hotel Enchanto, AirPort Road. The person Gunindro is a neighbour residing just adjacent to my residence. Since the day she went missing it was known to everybody in the locality that my wife was missing and that I had also lodged a complaint to the PS for finding her. As they were working together in the same place my family had also enquired about my missing wife to Gunindro but he totally denied having any idea about her whereabouts. It may be also mentioned that they used to work in the same company and both of them were terminated from their job recently. But today they were found together in the said hotel and the circumstances how things have unfolded hints to a larger conspiracy of carrying out much more grave offences by M. Gunindro Singh. There is a great possibility of M. Gunindro luring or threatening my wife to follow his dictates of saying that she left her home on her own or that Gunindro has nothing to do with her. Needless to say, the threats and sinister designs of M. Gunindro must have easily influenced my wife to give distorted statements to the police. The facts and circumstances and involvement of certain scrupulous elements could only be established with a thorough investigation. Also, all this time M. Gunindro had committed the grave offence of hatching a conspiracy, kidnapping my wife, cheating, and also keeping the police in the dark with the ulterior motive of extorting, sexually abusing and even taking her life he needs to be booked and investigated.

In the light of the above stated facts, it is requested to take befitting action against M. Gunindro as per law in the interest of justice,
