Today i.e. 11th Sept, 2024 at @ 4.35 PM, found a series of derogatory statement in social media posted by one Facebook user namely "Licypriya Kangujam". The statement is reproduced as follows "Kuki area da internet thingloi, Meitei area da internet thinggadabani order thoklibako. Mikithigeleingak, mikithige Govt. Minai oibiu."

Her post translates as follows "Internet will not be ban in Kuki area, Order has been issued to ban internet only in Meitei area. What a cowardice Government, Be a slave."

On the same day the same Facebook user uploaded a security arrangement program order dated 10/9/2024 regarding the movement of Hon'ble Governor of Manipur on 11/09/2024 signed by Dr. Dhanapiyari B., Superintendent of Police/CID (Security), Manipur with the caption "#Breaking #LatestUpdate Manipur Governor is planning to run away today from Imphal, Manipur to Guwahati at 9.15 am via Indigo Flight instead of consolidating both sides to restore peace. Manipur deserves to free from all such spineless people."

The derogatory statement posted by the Facebook user "Licypriya Kangujam" and those who have commented in his Facebook post provokes the general public to escalate the ongoing crisis in Manipur. The Facebook post also not only insult and defame the Hon'ble Governor of Manipur but, also to cause fear and alarm the general public, or to induce any person to commit any offence against the public tranquillity and incites any class of community promoting enmity, hatred or ill-will between classes on the ground of religion caste or community.

Hence, a suo-mottu case under FIR No. 468(09)2024 IPS U/s 356(2)/351(2)/196(1)(a)(b)/353(1)(b)(c)(2)/61(2) BNS has been registered for investigation.




