12. **First Information contents:**

Today i.e. 11<sup>th</sup> Sept, 2024 at @ 5.00 PM, found a series of derogatory statement in social media posted by one Facebook user namely "Domba Angom". The statement is reproduced as follows "Net thingdringei wa amta haihougey koktang sakthu gayjao panty fao setpa channaroi nangdi."

His post translates as follows "Before the internet is ban, I would like to say something, baldhead Gay boy, you are not even fit to wear panty"

On the same day the same Facebook user further posted that "Resign toubase mi hounabro Suicide touramdaida ei sidoire amta khamako haibaga kari khetnarigey ayoo thi yaore."

His post translates as follows "Do we inform the people for resignation, what is the difference, saying I am committing suicide, please stop me."

The same Facebook user also posted that "Bee Rain do oina thagey thagro da Japan da." His post translates as "send Bee Rain to Japan instead"

The derogatory statement posted by the Facebook user "Domba Angom". and those who have commented in his Facebook post provokes the general public to escalate the ongoing crisis in Manipur. The Facebook post also not only insult and defame the Hon'ble Chief Minister of Manipur but, also to cause fear and alarm the general public, or to induce any person to commit any offence against the public tranquillity and incites any class of community promoting enmity, hatred or ill-will between classes on the ground of religion caste or community at this juncture of crisis in Manipur.

Hence, a suo-mottu case under FIR No. 471(09)2024 IPS U/s 356(2)/351(2)/196(1)(a)(b)/353(1)(b)(c)(2)/61(2) BNS has been registered for investigation.


