**12. First Information contents:**

Today i.e. 13<sup>th</sup> Sept, 2024 at @ 4.00 PM, found a viral threatening statement in social media posted by one Facebook user namely "Licypriya Kangujam". The statement is reproduced as follows "Internet thingba, curfew thamjinba, students protestor 650 henna hatpa, Bangladesh ki hannage PM Shekh Hasina su yamna fajana toukhi, adubu failed oikhibani. Prajana amuk onkhatlakpada police officer 44 yaona constables 200 hennasu furaga hatkhi. Maduge tactics tu hujikti chatnadre. Right to peaceful protest ti yahallu."

Her post translates as follows "Ban of internet, imposing curfew, killing more than 650 students protestors, Former PM of Bangladesh Shekh Hasina also handled the situation at her best but failed at last. When the people started retaliation, 44 police officers including 200 constables were beaten to dead. However, the tactics is no more applicable. At least allow the right to protest peacefully."

The threatening statement posted by the Facebook user "Licypriya Kangujam" and those who have commented in his Facebook post provokes the general public to escalate the ongoing crisis in Manipur. It is also learnt that face book user "Licypriya Kangujam" is operated and handled by the father of the minor child "Licypriya Kangujam" namely Kangujam Karnajit Singh S/O K. Ibotombi Singh of Khongman Bashikhong Wangkhei Lou Manbi, Imphal East. The viral Facebook post not only threat or intimidate or warned the government of Manipur but, also create fear and alarm to the general public and induce any person to commit any offence against the public tranquillity and incites any class of community promoting enmity, hatred or ill-will between classes on the ground of religion caste or community.

Hence, a suo-mottu case under FIR No. 472(09)2024 IPS U/s 147/148/356(2)/351(2)/196(1)(a)(b)/353(1)(b)(c)(2)/61(2) BNS has been registered for investigation.
