Received a transfer case from OC/KPI-PS under FIR No. 0(230)(9)2024 KPI-PS U/S 380 IPC Mrs. Lhingjachin Haokip (48) yrs. d/o (L) Kamlal Haokip of Old Lambulane, Imphal West District, Manipur lodged a written report to OC/KPI-PS stating that due to ongoing state turmoil between Meitei and Kuki-Zo communities which suddenly broke out on 3<sup>rd</sup> May, 2023. So, she left her residential house along with all her household properties unattended located at Imphal, Old Lambulane, Imphal West on 5<sup>th</sup> of May 2024. However, she learnt that during the first week of September, 2024 at night some unknown miscreants forcefully intruded into her residential house, damaged and looted all her belongings approximately estimated at about Rs.8,95,500/- (eight lakhs ninety-five thousand and five hundred only).


