12. First Information contents:

Today i.e. 19th Sept, 2024 at @ 4.50 PM, found a viral video of unknown armed miscreants with threatening statement to the general public in social media. The threatening statement is reproduced as follows "Ngasi tang nipan tha mapan 2024 pung pham asida khun ngakpa singi maigei dagi leipak miyamda karigumba aphan khara thamjari madudi, tha tara taruk henjanlakaba laan sida tumpham chapham khangdana tin kang marak sida Kuki thengnanaba hotnaduna lakli ngasi2 mak su thengnari Kuki singna drone amadi missile sijinaduna Meitei da landaraklaba phoubada Meitei eikhoi masel punsinduna laan sida thawai khubak haptuna Kuki thengnanaba hotnariba singbu henna mathouna hapagi mahutta election gi vote khombadouna eikhoi masel social media da hunaduna leiribasi ngasi haiba numitsidagi tokpiro maramdi masina khun ngakliba eikhoida aduki matik pukning wakhal sothahanli, relief camp tah leiriba awaba kaya khangliba ereicha singsu laan si Meitei eikhoi thengnadaba yadraba laan ni, laan sigi awaba kaya si eikhoi punna khangminasi, ngasi eikhoina laan si thengnahoudraba amadi laan si eikhoi masel hunari ngaida ngamhoudraba Meitei haiba phurup si mutkhiba yai wasu wana epa epu gi ekheng tana yatuna thambiramliba eikhoi ema leibak Manipur kanbada punna mayok yaminasi khun ngakpa singna ngasi haiba numit sidagi leibak miyam da point mari khak toubinaba haina ningsingjari madudi ahanba point da social media da individual oigera political party oigera, nupi oigera nupa oigera CSO sing oigera eikhoi masen hunabagi post amata thagatpa yaroi. Combing operation touduna khun ngakpa singdagi makhal amatagi khulai loukhatpa yaroi, ruling amadi opposition na laan sidagi esa esagi political mileage lounaba hotnariba sing pungpham asidagi tokpiro masida Congress, BJP, NPP, good governance party sing eikhoida khetnaba amata leite, Meitei hairiba phurup si leitrabadi political party su leiroi. Masida ahei asing saduna social media da TV da leibak ningba sabagi thabak sing ngasidagi tokpiro hairiba singsi thawoi wawoidaduna social media da TV discussion da eikhoi masel hunabagi thabak se amuk chatharaklabadi amamam ta oina cheirak pigani, ngasi piriba message sina aroiba message ni, makha taba message haibabu khut thaba natana upai leite eikhoidasu, leibak miyam na warep singsida waroubiroi, ema leibak kanbada punna saruk yaminasi, apunbanayaiphare."

Their post translates as follows "Today 9th of Sept., 2024, at this hour on behalf of village volunteer we would like to say some words to the general public that the war has been going on for more than sixteen months we neither get to sleep nor eat while facing Kuki in the jungle. Today itself we face the Kuki attacking Meitei by using drones and missiles and instead of uniting all the Meiteis together we are fighting among our self in social media and TV discussions, this has to be stop from today onward, if not the Meiteis who are at relief camps suffering with hardship will go in vain, we have to fight this war if not Meitei community might be wiped out totally that's why everyone

should help face this war together. At this time, we the village Volunteer would like to give four points to the general public, that is number one, in social media no one should post anything against each other weather it may be individual male or female, political party or any CSO. Any kind of weapon should not be taken from the Village Volunteer by conducting combing operation. Any ruling or opposition political party should stop taking political mileage, whether it may be Congress, BJP, NPP, or good governance party there is no difference, if there is no Meitei community there will be no political party. Stop acting over smart in social media, TV acting patriotic. If anyone ignoring our message and started arguing among our self in social media and TV discussion, they will be punished individually. This is the final message; the next message is we have no choice but to take up action. Help us save our motherland, Unity is Strength."

The threatening statement posted by the unknown armed miscreants directly threatens and intimidates the general public which creates a fear psychosis in their mind at this juncture of crisis in Manipur.

Hence, a suo-mottu case under FIR No. 479(09)2024 IPS U/s 310(6)/351(2)/61(2) BNS & 25(1-B) Arms Act. has been registered for investigation.
