The brief fact of the case is that today i.e 20/09/2024 at @ 08.30 PM, found one baseless, unfounded, fabricated and provoking news item in page No. 1 of Manipuri Daily Newspaper "Huiyen Lanpao" (Manipuri Edition) Dated 18th Sept, 2024 publishing with the heading "Meeyamna Pamlibasi India leingakna tangdu leitaba puraktrabadi "pre-merger status" ni. - L. Nganbi.

The contents of the news item is reproduced as follows, "Manipur da tha tara taruk henlaklaba Phoubada Kuki gi laan loishinba Ngamdaba Haibasi India Leingak ki Khut Yaogani Haiba Takle. Manina maramo iraga hujik miyamna pamlaklibasi India leingakna tangdu leitaba puraktrabadi, "pre-merger states" ni haina apunba Manipur Kanba Ema Lup (AMKEL) gi president Lourembam Nganbina Phongdorakli.

AMKEL gi president na Pao cheasida hai, ngasiphoubada chatharakliba thawong sing yenglurabadi pre-merger states laothokpirakpana henna pamle, masinasu henna phagani. Meitei gi ee chenliba amadi yelhoumigi ee chenliba Naga amasung atei phurupsingnasu Political gi oiba lambida achumba purakpa pamlibani. Eramdam Manipur hujik masana leingakchaba matam oirakle. Pamdabagi meirina khangba ngamlaktabadagi meeyamna hourakpa ehon asi kadaidagi houraklibano haibadu leingak amadi state police amadi force singna khangpham thok e. Masigi onna teinabada, meeyamna ehon hourakle haiduna yumdasu tear gas kapshinduna puknungi angang phouba sire. Kuki na leibak amaga amaga tounaba laan da siginagadouba drone bombing amadi rocket bomb siginaraklabasu tumina khut-handana leiriba karigino hangkhi. Makhoina kapsinlakliba bomb-top sing state amadi central force singna chap chana handuna takthokkhiba haibasi security force ki mathouni. Soogi kukisingda khut handuna makhoina kaplakliba khudinggi chap chana paokhum pigadubani. Makhoibu designated camptagi hendokhalloidabni. Makhoidadi kaptraga pendraba meeyamna erang hourakpada karigi saopham thokpage hangkhi.

Koutruk ta mapam da lakchabi nupi amabu drone bombing chattharaktuna hatkhi. Moirangda arangpham phamba amasu rocket bomb na panbadagi sikhi. Nongma-nongmagi eikhoigimeesing hantharaklaga meeyamgi ehon lakkanu haibasi yaroi, khambasu ngamloi. Maramdi houjikkhakki nattana tha 16 leirakpa pendaba kayana thumhatlaga leirakliba meeyamni haibasi Manipur leingak amasung masigi

forcena khangdribasi angakpa faoe. Kukisingna sijinnarakliba khutsu khullaising kadaidagino haiduna neinaba houraklabani. India, China amasung Americagi khutlai yaore haina puthoknarakli. China amasung America yaorakle hairagadi India leingakna karigi khangdabano hangkhi.

AMKILgi presidentna mahakki oiba waphamni hairaduna kukisingna sijinnarakliba khutsu-khullaising asi India leingakna piba khutlaini haibada haimanba thoklaroi hairakkhi.

Ngasi faobada Manipur leingakta yaoriba MLA sing karitouraga leiribano hangladuna leibak ngakpa, mafurup kanba ngamdraba amadi kukinasu khutlai makhal kaya sijinnaduna hatlakpa leptraba faobada India leingakki yathang ngaiba mathou taribra hangkhi.

State amagi leingakki mathou amasung hak faoba mapung fana sijinnaba ngamdrabadi Delhi da meeyam thaduna haihallo amasung laohallo, masi karigi ngamdribano hangkhi.

Chief Minister ama oiraga ngaihak leiraga ama haiba, ngaihak leiraga ama ngangba theidoktheijin touduna ngangba leppiro. Loubayaba, stable oiba waa munna khangtharaba matungda ngangbiro nattrabadi meeyamgi eehoudagi leibakasi kang-khong chairakloi hainingai leite. Narco terrorist singna meecham hatpaga thabak asi malemgi meeyamna yade haibasi lina khangnaribani. Masida kuki narco terrorist singna chattharakpda ARna mateng pangduna ngak-sellaga thambasi meeyam pumnamakna khangnarabani. India leingakna Manipurgi yelhoumee Meeteibu mutthatpa pambagi lallongni haibasisu haimanba thoklaroi haikhi.

May 3, 2023 dagi india leingakna karimata toudana leiralibasi da meeyam pendre. Central force mayam karisu kannadre hairaduna pumnamak louthokkraga state force ta sinnaramba adu meeyamna pamle. Article 355 chatnare hairi adubu India leingakna paikhatpham thokpa thabak amata paikhattri. Maramasina makhoigi lallongda thuduna leiriba Manipur leingakki assonbada meeyamna pennadbani. Leibak ngakpa ngamdrabadi meeyamda sinnabiro, meeyamna India leingakka thengnajarage hairakkhi."

The news item is translates as follows," The never ending Kuki war which last for more than 16 months in Manipur indicates the involvement of Government of India. It is therefore the people of Manipur will like the "Pre-Merger Status" if the Government

of India does not resolve the crisis peacefully as stated by the President of AMKIL, Lourembam Nganbi. The President further stated that looking into the ongoing crisis the people of Manipur prefer the pre-merger status, this will be better. The indigenous people of Manipur including the Nagas and other communities are longing for a right path of political solutions. Now it becomes inevitable for self governance. The Government, the state police and forces must understand from where did the rebellious protest started by the peoples against the Government in discontented. Instead the tear gas which was used to control the protest resulting in the death of unborn foetus. Why the Government is still silent when the Kukis attacked by using drone bombing and rocket bomb which is used in a large scale wars between different countries. It is the duty of the State and Central forces to retaliate and flush out. The Kukis under suspension of operation must be attacked and retaliate. They must be put inside their designated camps. Instead of attacking them why you are angry when the people started protesting. A woman who came to his parental home was killed by drone bombing at Koutruk. A religious event arranger was killed at Moirang by Rocket bomb. When the population is decreased day by day, you will not be able to control the public outcry. It is very unfortunate that the 16 months long crisis is not acknowledged by the state Government and its forces. It is started discussing that from where the weapons used by the Kukis coming. It is revealed that the weapons made of India, China and America is present. She asking that why the Government of India is not aware if there is involvement of China and America. The President of AMKIL further stated that it must admit that the weapons used by the Kukis are supplied by Government of India. She further ask that what the ruling MLAs are doing till date and is it necessary to wait the order of Government of India even they cannot save their own peoples while the Kukis started killing by using different sophisticated weapons. If the state government cannot utilize power and right, let the people go to Delhi and raise their voice. Being a Chief Minister and who cannot stand by a firm decision, so please stop speaking different narratives. Please take a firm and stable decision, and speak. The outcry of the people will be very violent. The killing of innocent people by the Kuki Narco terrorists is acknowledged by the international community. Everyone knows that Kuki Narco terrorists are supported by the Assam Rifles. It is not wrong to say that the Government of India wanted to eliminate the indigenous Meitei people. Everyone is


unsatisfied to the Government of India being a mere spectator since 3rd May, 2023. All the central forces are useless and wished to remove all from the state and people wants state force instead of central force. Article 355 has been implemented but the Government of India is doing nothing. So, people are not satisfied with the State Government who only waits for the order of the Central Government. Let the people rule the state if you cannot rule and people will face the Government of India."

The newspaper publication overtly contains false imputations against the Hon'ble Chief Minister of Manipur falsely alleging that the Chief Minister has been making incoherent statement at different time, without specifying what those alleged incoherent statements are and these imputations have been published with intention to be read widely to harms and knowing and having reason to believe that such false imputation will harm the reputation and defame the Hon'ble Chief Minister of Manipur.

The statement made by the president of AMKEL, L. Nganbi Devi is an attempt to abet waging of a war against the Government of India by conspiring with the Editor and publisher of Manipuri Daily Newspaper "Huiyen Lanpao" (Manipuri Edition). As Manipur is one of the States in the Union of India. The Editor and president of AMKEL, L. Nganbi Devi are well aware that calling for pre-merger status by way of written explicit material published in the newspaper amount to calling upon the citizen of India to wage war against the Government of India to secede from India.

The bias news item provokes the general public to escalate the ongoing crisis in Manipur. The editor published the baseless, unfounded and fabricated news in collusion with president of AMKEL, L. Nganbi Devi in the midst of the crisis without proper verification which misleads the different communities and promotes hatred, enmity, revenge and retaliation at this juncture of crisis in Manipur.

Hence, a suo-mottu case under FIR No. 480(09)2024 IPS U/s 147/148/356(2)/196(1)(a)(b)/351(2)/353(1)(b)(c) & (2)/61(2) BNS has been registered for investigation.
