**Sub: Prayer for further investigation with regard to Kangpokpi PS vide FIR No. 0(184) (05) 2024 KPI-PS u/s 427/380/448/34 IPC**

We are a Company registered under the Companies Act and duly licensed by Insurance Regulatory & Development Authority of India (IRDAI) to carry out the business of General Insurance in the country.

We are in receipt of a Claim no. 4400016190A for an alleged burglary incident involving Nazareth Clinic & Diagnostic Centre situated at 5<sup>th</sup> Avenue, near 2<sup>nd</sup> MRGate, Imphal East, PO & PS- Porompat, Manipur-795001. It was alleged that all the properties (worth Rs. 5.3 Crores) inside the premises were taken away by unknown miscreants on 16<sup>th</sup> May 2024 midnight.

The Proprietor of Nazareth Clinic & Diagnostic Centre nameily Dr. H Jamkholal Haokip had lodged a zero FIR at Kangpokpi police station vide FIR No. 0(184) (05) 2024 KPI-PS u/s 427/380/448/34 IPC on 21/05/2024. Later, the case was transferred to your PS and a new case was registered at your PS vide FIR no.: 315(05) 2024 IPS u/s 427/380/448/34 IPC on 26/05/2024.

Notably, the Proprietor of Nazareth Clinic & Diagnostic Centre namely Dr. H Jamkholal Haokip had bought a Business Guard Laghu Package Policy vide policy no. 5130017241 on 17/06/2023 from our company through Axis Bank Channel. And, the claim was lodged on 22/05/2024 through a claims consulting agency namely Lifeboat.

In due course of the claim, Dr. H Jamkholal Haokip had submitted seven Invoice copies pertaining to M/S SYSTOLE SURGICAL having particulars of all the plant and machineries, equipment etc. Which were allegedly stolen. The SYSTOLE SURGICAL is situated at Khoyathong, Opposite ABC Goddown, Imphal-795001 (Imphal). During the course of Verification, the proprietor of SYSTOLE SURGICAL namely Yengkokpam Netrajit Singh, Slo: Y Irabot Singh had clearly mentioned in the letter head of SYSTOLE SURGICAL that these invoices were not genuine. Yengkokpam Netrajit Singh had also stated that Dr. H Jamkholal Haokip of Nazareth Clinic & Diagnostic Centre had many a times requested him to provide some invoices against a list of items which were not purchased from SYSTOLE SURGICAL. Although initially, Mr. Yengkeknam Netrajit Singh did not entertain Dr. H Jamkholal Haokip but later, after several requests he had provided these invoices to Dr. H Jamkholal Haokip just for record purpose.

Based on the above information and documentation, it appears to be a fistitious matter and the malicious intent of the Proprietor of Nazareth Clinic & Diagnostic Centre is manifest that requires

further investigation. All the invoice copies and the declaration letter of Proprietor SYSTEM SURGICAL are enclosed herewith for your perusal and necessary action.

As such, we humbly request you to arrange further investigation into the matter so that the true facts are unearthed.


