Today i.e. 24th Sept., 2024 at @ 87.10 PM, found a viral publicity note in social signed by Kanny Park at @ 87.10 PM, found a viral publicity note in social Chinaburoi. Tamburoi media signed by Kenny Roel, Secy. Information & Publicity, Chingburoi Tamburoi Apunba Lup (CTAL) Roel, Secy. Information & Publicity, Chingburoi Tamburoi Apunba Lup (CTAL) in their letter head Ref No.17/02/CTAL(PR)/2024 dated 23/09/2024. The contents of the derogatory and threatening publicity note are reproduced as follows "Thaina Maharaj Bhagyachandrana Langthabal konnung dah pallingei Kangi (China)macha ama Kangleipakki lamdam dah khongsallakkhi. Kangi amadi Kangleipak ki marithadatnanaba Shantidas Gosai naoidaba pao sandok tuna Kangi (China) nupa asi hingchabini aduna nongma dah jiba cha-amaman chai haijin duna phahllaga mangak kakthathalli aduga makok buna Kangla dah phumhalli. Mungphom mathak tudah Luphounung nansil halli. Makha tabadah Bhagyachandra bu ningthi turel gi eeshing thaknanaba khanghallam e. Bhagyachandra na ningthi turel gi eeshing thakpah chatlubada hyeknabana khudum chanduna hattokpikhi. Ngasi Meitei khunnai na khanggadaba amana Shantidas Gosai na Bhagyachandra dah sanabibagum Amit Shah amadi Modi na suh N. Biren Singh haopang dah asum asum sanabiduna houjikti makhut makhong punsinbiraga eramdam Manipur bu machete machete tananaba sinduna lakli.CM gi choukri tannabada Kuki militant singga khongloi e. Naga gi NPF MLA sing gi support phangnanaba NSCN(IM) ga amuk khongloi e aduga Tangkhul singbu ee-jamba ni amuk hai. N. Biren Singh na Manipur machete machete tahendri ngei, AT, ML amadi VBIGs ya-olloi echin enao singna jaragadi N. Biren Singh sebo phabiro aduga mula toubiraga makok Kangi (China) nupa phumphom dudah phumbiro aduga Luphounung nanhanbiro eramdam ephurup kannanaba."

The derogatory and threatening publicity note of Chingburoi Tamburoi Apunba Lup (CTAL) translates as follows "Once upon a time when Maharaj Bhagyachandra was sitting on the throne of Langthabal Konnung, one Chinese came to Kangleipak. In order to break the ties between China and Kangleipak, Shantidas Gosai spread a rumour that the Chinese was a Demon and that she eats one human every day, thus she was caught and cut off her head and her head was buried and overlaid by a big stone called Luphounuung at Kangla. Thereafter Bheigyachandra was advised to drink the water from Ningthi River, when Bheigyachandra went to drink the water from Ningthi River he was overpowered and executed. From now on the Meitei community should know that, like what Shantidas Gosai did to Bheigyachandra back then, now Amit Shah and Modi is doing with foolish N. Biren Singh by playing with his mind, tying his hands and legs, and trying the break Manipur into pieces. In order to get CM's chair, he joined hands with Kuki Militants. To get support from NPF MLAs he also joined hands with NSCN (IM) and he claims that Tangkhuls are elder brothers again. Before N. Biren Singh breaks Manipur into pieces, AT, ML and VBIG's revolutionary brothers please catch him and cut off his head and bury him at the place where the Chinese was buried and overlaid by a big stone called Luphounuung at Kangla."

The derogatory and threatening publicity note of Chingburoi Tamburoi Apunba Lup (CTAL) provokes the general public to escalate the ongoing crisis in Manipur. The publicity note not only insult, defame and threatened the Hon'ble Chief Minister of Manipur but, also to cause fear and alarm the general public, or to induce any person to commit any offence against the public tranquillity and incites any class of community promoting enmity, hatred or ill-will between classes on the ground of religion caste or

community at this juncture of crisis in Manipur.

Hence, a suo-mottu case under FIR No. 482(09)2024 IPS U/s 351(2)/356(2)/196(1)(a)(b)/353(1)(b)(c)(2)/61(2) BNS has been registered for investigation.
