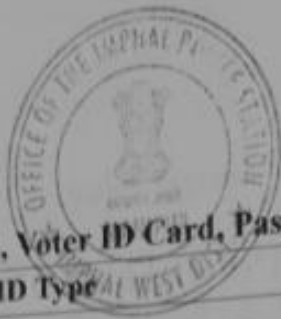

Today i.e. 27th Sept, 2024 at @ 3.20 PM, found a threatening statement viral in social media posted by one Facebook user namely "Meitei Nongsa Lamyamba". The statement is reproduced as follows "Date 28 se Saa kharadi hattwri ngaibada ware..... Ready Dane leise". His post translates as follows "Tired of waiting for 28th September, 2024, as some animals will be killed, I am ready for it".

The threatening statement posted by the Facebook user "Meitei Nongsa Lamyamba" in his Facebook post provokes the general public to escalate the ongoing crisis in Manipur. The Facebook post also causes fear and alarm to the general public, and induces any person to commit any offence against the public tranquillity and incites any class of community promoting enmity, hatred or ill-will between classes on the ground of religion caste or community at this juncture of crisis in Manipur.

Hence, a suo-mottu case under FIR No. 486(09)2024 IPS U/s 351(2)/196(1)(a)(b)/353(1)(b)(c)(2)/61(2) BNS has been registered for investigation.
