Sir,

With due respect, I have the honor to state the following few lines for your kind perusal and further necessary action to take up a regular FIR and to book the culprits according to the law of the land.

That, in the intervening night of 28th and 29th Sept, 2024 at @ 12.50 AM, three unknown persons who came on one motorcycle fired 10/11 rounds of bullets at my bed room and main entrance gate while I was sleeping with my wife along with my daughter inside the bed room. Some bullets were penetrated through the window pane causing damage of wall inside my bed room. Fortunately, no one was injured due to the firing. The unknown miscreants fled away from the spot towards western side of Hodam Leirak after commission of the crime. Later on, today morning one unknown person has sent me some threatening message from one phone No. 7085396881. As a result of the incident and threatening phone calls and messages, my whole family is mentally and physically disturbed thereby causing fear psychosis to the small children of our family and old aged parents.

It, is therefore, requested your good self to kindly find out the culprits according to the law of the land at the earliest.




