Sir,

I am a driver by profession. On 24/09/2024 I returned from Silchar and at about 3:00 p.m., I parked my Tata truck of 12(twelve) wheel at Lairenpat at M/s Ibetombi oil pump on the Southern side of the pump adjacent to their building. I told the pump employee that I have parked my Tata as it was also done earlier since May 2024.

That, on 27/09/2024 at 2:30 p.m., when I went to Lairenpat to take my Tata to go to Jiribam for a run, in my utter surprise the Tata Truck was not found. I asked the owner to trace the GPRS installed in the Tata Truck and then the owner told me that as per the GPRS the Tata Truck had driven away on 25/09/2024 at 10:11 p.m., and seen at Tharoijam Leikai in Konthoujam. The Tata registration No. is ML04C9732, Chassis No. MAT466450K5J15373, Engine No. 91J63809517 Body Type Punjab body, Model 2019 and recorded in the name of the owner Marchal Suting of Shillong, Meghalaya. I could not report the matter in time as we were searching for the Tata Truck here and there but could not found. The documents of the Tata Truck and the required information are enclosed here with for reference.

It is requested to kindly arrest the miscreants and recover the stolen Tata Truck.
