Today i.e. 07/07/2024 at 7:15 pm received an information that on the same day at about 7:10 am one unknown Royal Enfield bullet motorcycle who was coming along BT road from Shamu Makhong side towards Western gate of Kangla, Imphal was knocked down in front of Congress Bhavan, Imphal by one unknown Tata truck (Water tanker) which was coming on the same route due to rash or negligent driving on the part of the unknown driver of Tata truck (Water tanker). As a result, the rider and pillow rider of the unknown Royal Enfield bullet motorcycle received injuries on their person and evacuated to Hospital for medical treatment and also the unknown Royal Enfield bullet motorcycle was partly damaged.
