Today i.e. 23/06/2024 at around 7: 30 Am received a reliable information that on the same day at @3:10 am. One bomb blast/explosion sound hard from the North east direction of BBK-PS. In this regards, our police team rushed to the said direction and found one dwelling house owned by one Tongbram Subash Singh (53) yrs. S/o (L) T. Angouba Singh of Goakhal at present Game Village zone IV Lairembi Leikai Imphal West was damaged due to bomb blast by planting the unknown suspected armed kuki militants.

Hence a suo motto case under **FIR No. 13(06)2024 BBK-PS U/s. 400/427/436/34 IPC& 25(1-C) A. Act. & 3 Explosive Sub-Act.** has been registered for investigation.
