In this regards, our police team rushed to the said direction and found one store room owned by one Ningthoujam Biramohan Singh (54) yrs. S/o (L) N. Birababu Singh of Harinagar Village was damaged due to bomb blast by planting the unknown suspected armed kuki militants.

Hence a suo motto case under FIR No. 14(06)2024 BBK-PS U/s. 400/427/436/34 IPC& 25(1-C) A. Act. & 3 Explosive Sub-Act. has been registered for investigation.
