On 24/07/2024 at around 7.20 am I went to the said house and working surrounding my house till 5:00 pm. Then I left from my house. Then on the same day at about 7:20 pm .i heard that my house was burnt down by some unknown miscreants. As a result of which my house was totally burnt down including wood and readymade door and window. The approximately value of the damage house is about 2, 50,000/ (two lakhs fifty thousand) only.

It is therefore, requested kindly to take necessary action against the culprit.
