In the information I have confirm that my house and its house on property was fully burnt Solar plate with Battery set, Smart TV set, Woffar, Godrej, 2 nos. water pump (motor), 4 nos. selling fan, 1 no Refrigerator, 1 no Washing machine , 3nos. wooden Bad with mattress, 5 nos. Blanket, 3 nos. Mosquito net, 1 no. Gas cylinder with stove and kitchen items, 1 no. Dining Table with 8 nos. Chiar, 1 no. Sentex, 2 nos. Brite, 2 nos. water pipe coil and 2 nos. PVC electric wire Coil. The approximately value of the burnt down house and properties is about 10, 00,000/ (Ten lakhs).
