Sir,

I have the honour state that on 08/09/2024 at around 9:40 Pm one bomb blast / explosion sound was heard from the unknown direction when I was at relief camp at BBK-PS. I could not know that my house was damaged due to bomb blast and there was no chance to know because last night, It had been heavy raining. On next day i.e 09/09/2024 at around 5:00 AM my son Haobijam Nanao Singh went my house and he informed me on mobile phone that my house was damaged. The bomb was suspected to have planted by some unknown persons hereby attempting to life of our family members. In that I also went to my house and found that one bomb was blast at the back side courtyard near house. In the bomb blast, the back door and window glass of my house was partly damaged due to sound effect of the explosion and one store room also partly damaged. The total approximate value of my partly damaged property is 4 (four) Lakhs.

It is therefore, requested kindly to take necessary action against the unknown persons according to law.
