I have the honour to state that, I and one Pebam Rajkumar Singh (63) Yrs. S/O. (L) P. Ibungoton Singh of Borobekra are living together in the abandoned building of old Primary Health Sub-Centre Borobekra. Since 2019, the function of the said PHC, was shifted to the new PHC building at Goakhal Village. Then, I along with Pebam Rajkumar Singh (63) Yrs. S/O. (L) P. Ibungoton Singh of Borobekra live together as care taker of the said abandoned PHC building at Borobekra. In the present conflict situation of Manipur and Borobekra Sub-Division, I along with Pebam Rajkumar Singh have shifted at the Borobekra Police Station Relief Camp. On 12/09/2024 at about 1:30 pm one VDF Md. Hason Ali of Borobekra Police out Post called on phone to me that on the same day at about 12:30 am the said building was burnt down by some unknown persons. The suspected unknown persons have burnt down for attempting to life of our family members .In the burning the said building was fully damaged. The total approximately value of the building and its property is 4 (four) lakhs

It is therefore, requested kindly to take necessary action against the unknown persons. According to law.
