which was coming in opposite direction collided each other at Yairipok Bamon leikal near Kabarstan along Yairipok Khoirom road due to rash or negligent driving on the part of both the Honda Dio rider and Maruti Van driver. As a result of which the pillion rider and driver of Maruti Van with it's one occupant sustained injuries on their persons and evacuated to the Hospital for medical treatment. Both the vehicles were also partly damaged.
