

# 12. First Information contents:

Today i.e. 3<sup>rd</sup> Sept., 2024, at @ 5.40 PM, found a secret message of Manipur Police signed by L. Kailun, Addl. Director of Police (L&O) vide message No. QX-1/10/10-ADGP (L&O) dated 02/10/2024 which has gone viral in social media posted by one Face book page namely "PRJA" with the caption, "Stay alert ereichas of this land. Something sounds fishy here. What is this government upto? Isn't this L. Kailun a Kuki officer? What is he doing still under our nose?"

The contents of the message are reproduced as follows, "In view of the present law and order situation in the state, all officers, police stations, out posts, nakas etc. should remain high alert (.) Proper security for arm and ammunitions should be ensured (.) For information and necessary action please (.) Ends (.)."

Posting such secret information of Manipur Police in social media with the provoking and alarming caption by the Face book page namely "PRJA" at this juncture of crisis in Manipur directly compromise the internal security of the state which is a threat to the Manipur Police Organisation. Moreover, publishing such sensitive and secret message of Manipur Police provokes the general public to escalate the crisis in Manipur. The caption also promotes enmity between different groups and prejudicial to the maintenance of harmony between different ethnic groups residing in the state and is likely to disturb the public tranquillity, creating feeling of enmity, hatred or ill-will between different communities. Such alarming news may also induce any section of public to commit an offence against the state or against the public tranquillity.

Hence, a suo-mottu case under FIR No. 494(10)2024 IPS U/s 196(1)(a)(b)/353(1)(b)(c)(2)/356(2)/61(2) BNS & 3 (1)(C), 3(2), 5(d), 5(2), 5 (3) of Official Secrets Act 1923 has been registered against the administrator of the face book page "PRJA" for investigation.
