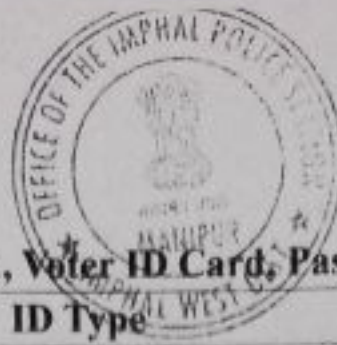

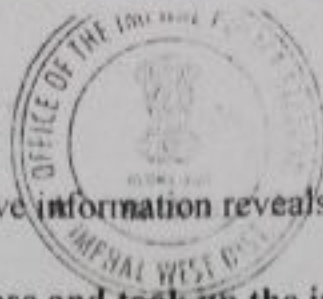
I therefore, requested you to kindly take the necessary steps to locate the scooter and legal action against the culprit(s) as per law.
