Today i.e. 5th October, 2024 at @ 08.30 PM, the Youths of Manipur organised a rally from Singjamei side towards the hyper sensitive zone of Babupara, Imphal as a protest against the arrest of one transgender Malem Thongam by Imphal East Police. The face book page namely Youths of Manipur also uploaded the live telecast of the rally and they provoke and induce the general public to join the rally to protest against the police and Govt of Manipur.

The viral Face book live streaming of the rally by Youths of Manipur and those who commented on the live streaming directly threat, intimidate and warned the Manipur Police and Govt. of Manipur to cause death or grievous hurt or to cause the destruction of Govt. property by fire. The Face book live streaming by the Youths of Manipur is also a direct provocation to the general public to riot against the Govt of Manipur and a malicious campaign to bring down the Govt. by a violent mob. The statements by Youths of Manipur also creates fear and alarm to the general public and induce any person to commit any offence against the public tranquillity and incites any class of community promoting enmity, hatred or ill-will between classes on the ground of religion caste or community. During the live telecast the administrator of the Youths of Manipur stated derogatory and threatening remarks to provoke the general public to escalate the ongoing crisis in Manipur.

Hence, a suo-mottu case under FIR No. 500(10)2024 IPS U/s 191(2)/109/351(2)(3)/196(1)(a)(b)/353(1)(b)(c)(2)/61(2) BNS has been registered for investigation.
