Sir,

I have the honour to state that on 22nd July, 2023 at a hotel located at Keishampat, CCpur Parking, I paid a sum of Rs. 5,00,000/- (Rupees five lakhs) only to one Konthoujam Ranbir Singh (31) S/o K. Binoy Singh of Konthoujam and Naorem Bishorjit Singh (36) S/o (L) N. Lolito Singh of Malom Tuliha, Imphal West, Manipur for purchasing a used car in which they promised me to buy it from Kolkata and deliver it to me. However, when they delivered the car to me on 5th Sept., 2023, it was found that the vehicle was not a genuine one. I requested them to exchange a genuine vehicle. However, Naorem Bishorjit sold out the same vehicle to someone else at the rate of Rs. 6,50,000/- nor returned my money. I have requested them several times to return my money but failed to return the same till date.

So, I therefore, requested you to kindly take up necessary legal action against them according to law.
