I have the honour to state the following few lines for your kind perusal and further necessary action at the earliest.

That today i.e. 7th Oct., 2024 at around 10.30 am, I visited Yambem Laba's residence with my husband namely Y. Bangkim Singh. While we were having discussion about the financial matter, suddenly, without any provocation Mr. Tony pulled out a gun from Yambem Laba's waist, cocked it, and pointed it to my head, threatening to kill me.
