Today i.e. 17/08/2024 at 02.30 PM, found one news item in one of the leading newspaper in Manipur "Huiyen Lanpao" (Manipuri edition) with the head line "August 13 gi concert ta chennabasing cheirak pikhrey". The headline is translated as "Punishment has been awarded to those involved in the concert of 13th August". The news item is reduced as, the valley based underground outfit UNLF ban the officials of AMFA involved in organizing the musical concert on 13th August, 2024 at Khuman Lampak Turf Ground, musical band - Innocent Eyes, Leipung, Pebet, God & Dog and the co-sponsor Mami-TV. Further, the banned outfit also instructed the executive members of AMFA to resign from their post and to re-appoint fresh members.


It is learnt that the banned outfit UNLF arrested the officials of AMFA and others who were involved in organizing the musical concert on 13th August, 2024 at Khuman Lampak Turf Ground and held captive in their custody by taking law in their hand.

Hence, a suo-mottu case under FIR No. 438(8)2024 IPS u/s 140/142/351(2)/3(5) BNS & 20 UA(P)Act has been registered against the valley based underground outfit UNLF for investigation.
