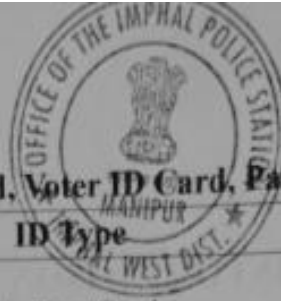

Sir,

I, the undersigned have the honour to report that on 10.09.2024 District Magistrate, Imphal West District, Manipur issued an Order dated 10<sup>th</sup> September, 2024 thereby imposed total curfew in Imphal West district with Immediate effect i.e from 11:00 AM of 10<sup>th</sup> September, 2024 until further orders due to the developing law and order situation in the district. That, as per Work Order bearing No.IW/AC/1-13/23,/70 dated 26/02/2024 issued by the Executive Engineer, Imphal West Division, PWD, Manipur my firm M/s Sansak Construction, 1<sup>st</sup> Class Contractor, Patsoi Part-2 Makha Leikai was allowed to execute the work for Improvement of roads in and around Imphal

(SH:-Road under Imphal West) including the area (location) of Imphal Market (Bazar) since February, 2024 and continuing the work till the issue of the Orders for curfew by using the following Machinery items: -

- 1) MINI HOT MIX PLANT (SINGLE DRUM), PRIMAX COMPANY, Cost of the Machine is Rs.6,50,000/- (Approx.), Owner of the Machine- P. Joyshanker Singh,
- 2) MINI HOT MIX PLANT (SINGLE DRUM), PRIMAX COMPANY, Cost of the Machine is Rs.6,50,000/- (Approx.), Owner of the Machine-M. Sharat Singh,

Received information from reliable source that both the Machines mentioned above which were parked at the foot of the Bir Tikendrajit Flyover bridge along UK Road, were gutted on fire by some unruly Mob/riot on 10.09.2024.

Accordingly, I along with the owners of the Machines mentioned above inspected the site of incident today, the 11<sup>th</sup> September, 2024 afternoon and found the Engine portions of both the Machines were fully damaged and cannot be repaired for further use. Hence, it is requested to register a regular FIR case for investigation minutely into the matter for taking further necessary legal action.
