Sir,

With due respect, I have the honour to report that on 14/9/2024 at @ 12.30 PM, I along with SI Chanuleima P., ASI Th. Saratchandra Singh and police team of Imphal PS went to the residence of the appellant Sagolshem Shyamkumar Singh S/O (L) S. Munindro Singh of Sagolbandh Moirang Leirak in compliance of Hon'ble District Judge, Imphal West order vide Judl misc Case No 91 of 2024 with reference to (i) Misc Civil appeal No 13 of 2024 (ii) impugned order dated 12/6/2024 passed in Judl Misc Case No. 291 of 2024 arising out of suit No. 19 of 2024 to restrain the appellant from making any further construction in the suit land. On spot checking, it was found that the appellant violated the Court's order and continued construction inside the suit land and the construction work was in progress. In the meantime, while explaining the order of the Hon'ble Court to the appellant, the son of the appellant namely Sagolshem Shyamson Singh (28 yrs) S/O S. Shyamkumar Singh of Sagolbandh Moirang Leirak who is a riflemen of 5th MR now attached to CDO Imphal West along with his sister and mother obstructed our police team while discharging our duties. They started assaulting the police officer on duty by using stone/bricks and other deadly weapons. They also provoke the local people by ringing the electric pole to obstruct the police taking the advantage of the ongoing crisis. My service ribbon was also snatched from my uniform by them and got damaged. As a result, I received injury on my face and body.

It is therefore, requested your good self to kindly take up necessary legal action against Sagolshem Shyamson Singh and his associates for obstructing police officers while discharging our duties and assaulting women police officer on duty by taking law in their hands.
