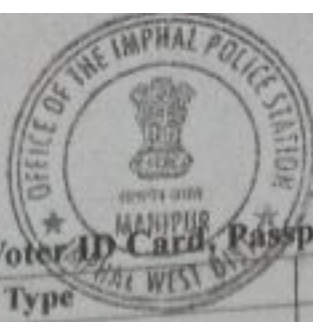

Today i.e. 18<sup>th</sup> Sept, 2024 at @ 4.30 PM, received reliable information that one Eric Thangjam aged about 40 years @ Thangjam Raju Singh S/O (L) Th. Ranjit Singh of Nagamapal Khwai Brahmapur Laimayum Leirak, P.O & P.S- Imphal, Imphal West District have uploaded a threatening whatsapp status in his whatsapp number 6009266950. The threatening status is reproduced as follows "Lmbida slogan laoba, rally chitpa, nung thombana kanaroi. BJP office thugaiyu. Biren and party gi mayum thugaiyo. Eikhoi leirak machin gi RSS office thugaiyo."

His post translates as follows "No use of shouting slogan in the street, marching rally, throwing stones. Vandalize the office of BJP. Vandalize the house of Biren and party. Vandalize the office of RSS office near the entry point of our lane."

The threatening whatsapp status posted by Eric Thangjam (40 yrs) @ Thangjam Raju Singh provokes the general public to escalate the ongoing crisis in Manipur. His status also not only threatened, insult and defame the Hon'ble Chief Minister of Manipur, members of BJP and RSS but, also causes fear and alarm to the general public, or induce any person to commit any offence against the public tranquillity and incites any class of community thereby promotes enmity, hatred or ill-will between classes on the ground of religion caste or community at this juncture of crisis in Manipur.

Hence, a suo-mottu case under FIR No. 478(09)2024 IPS U/s 148/356(2)/351(2)/196(1)(a)(b)/353(1)(b)(c)(2)/61(2) BNS has been registered for investigation.
