Today i.e. 28/06/2024 at around 11.30 am, it is learnt from social media that one unknown women wearing black clothes has shouted slogan against Kuki community "Kuki tumna hatkadabani, Kuki Manipur dagi maru fangna muthatkadabani" (All Kukis should be killed and eliminated from Manipur) when a Mass rally organized by The Co-ordinating Committee on Manipur Integrity (COCOMI) have reached near Press club, Imphal along NH-02. The slogan promoted enmity between different groups on grounds of religious, race, place of birth, residence, language etc. Spreading of such slogans affects the peace and harmony in the state and further she induces the minor children's which were part of the rally to shout such slogan to promote enmity among the communities.

Hence, a suo-mottu case under FIR No. 80(6)2024 City PS U/S 153-A/34 IPC & 83(2) JJ Act has been registered for investigation.
