Sir/Madam,I, Leimapokpam Sanathoi Devi, a resident of Chairel Khongnang Leikai, Kakching District, Manipur, am writing to formally lodge a First Information Report (FIR) regarding the illegal destruction of my property that occurred on the 18th of August,2024 at approximately 4:00 PM. On the aforementioned date, a group of local individuals, led by Khundrakpam Bala Devi, who holds the position of Meirapabi Secretary, unlawfully demolished the concrete wall fencing of my property using a JCB machine. This act of destruction was carried out without any legal authority or prior notice and has resulted in significant damage to my property. I have attached photographs documenting the extent of the damage as evidence of this unlawful act. In addition to requesting immediate legal action against the perpetrators, I also seek appropriate compensation for the damages incurred. The destruction has caused considerable financial loss and distress , and I believe it is just and necessary for the responsible parties to compensation for the damages caused. I kindly request that the matter be investigated promptly and that the responsible individuals be held accountable, Furthermore, I seek your assistance in facilitating the process for claiming compensation for the damages to my property. Thank you for your immediate attention to this grave matter. I trust that your esteemed office will take the necessary steps to ensure justice and appropriate redressal.

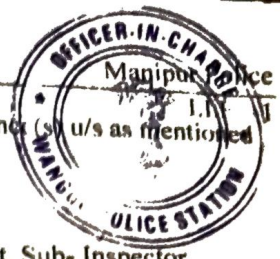


