On Questioning he identified himself as Wangkhem Sunil Singh @ Tomba (40) yrs. S/o. (L) W. Jugon Singh of Naranseina Maning Leikai, Bishnupur District, (A/P) Wabagai Bazar, Kakching. Thus, from the above facts and circumstances, he was arrested from the spot at around 3:15pm by observing formalities.

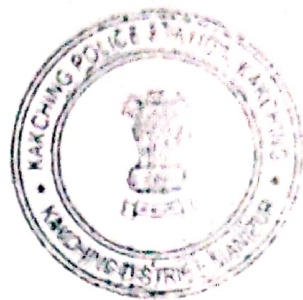

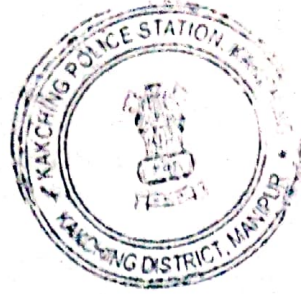
