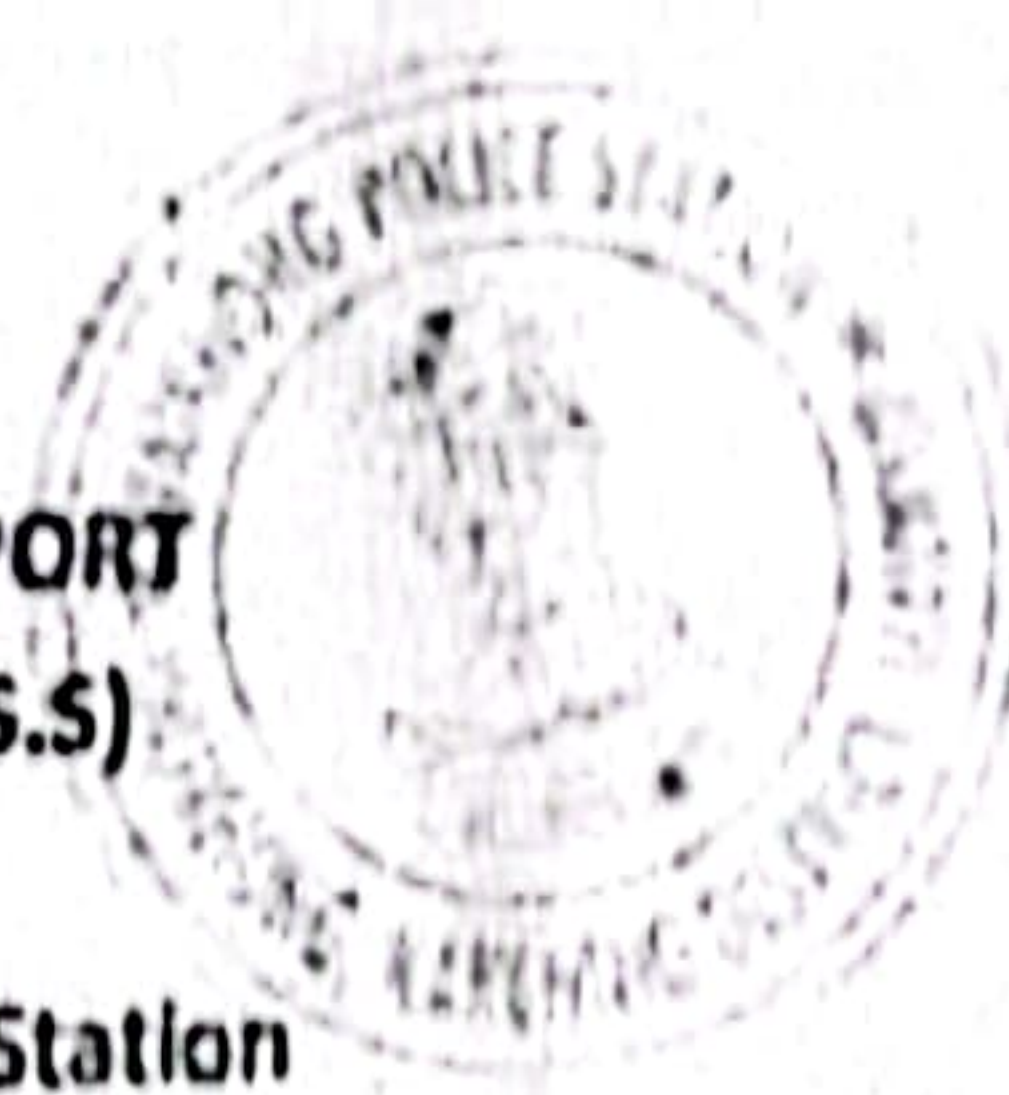

12. First Information contents: On 21/08/2024 at about 9:30 am one complainant namely Yumnam Shyam Singh Hav. No. 09941062, 7<sup>th</sup> IRB attached with CDO Unit/KCG lodged a written report to OC/WKG-PS stating that on 21/08/2024 at about 5:00 am, receipt of a reliable input from 46 Assam Rifles with respect to the presence of war like stores in general area of Ching Lukok near IVR road leading to Purum Pantha (under jurisdiction of Waikhong PS), a combined team of CDO Unit Kakching and a team of Waikong PS led by Inspt. Md. Jakaur Rahaman, OC/Waikhong PS under the command of Subedar Soraisham Birla Singh, OC CDO KCG, assisted by a platoon of A-Coy 126 BSF Bn led by SI Deep Kumar and a column of 46 Assam Rifles led by Maj Shivam Sachan, conducted CASO (cordon and search operation) at Ching Lukok near IVR road. The operation was started by 05:30 am and concluded by 07:30 am. After an intense search operation in the area, the following war like stores were recovered which were cached in the Jungle area of Ching Lukok. While checking the cached war like stores, it was found to conceal the following items: (1) 1(one) 51mm mortar without bearing Regd. Number, (2) 4(four) .36 HE Hand Grenade Indian made, (3) 1(one) Baofeng walkei talkie with charger, (4) 2(two) Single barrel local made, (5) 1(one) Carbine local made, (6) 1(one) Revolver local made, (7) 84(eighty four) Nos. of 5.56mm rounds, (8) 40(forty) Nos. shotgun cartridge, (9) 2 (two) Nos. of lathode bombs, (10) 7 (seven) Nos. Tear smoke shells, (11) 2 (two) Nos. Wood piercing shells and (12) 1 (one) No. Rubber bullet. As such the above noted warlike inventories have been recovered from the spot by recording (a videograph) of the action of recovery. Later, the recovered items have been formally seized at the spot at 07:20 am by observing formalities. I have the honour to report that today i.e. 21/08/2024 at about 5:00 am, on receipt of a reliable input from 46 Assam Rifles with respect to the presence of war like stores in general area of Ching Lukok near IVR road leading to Purum Pantha (under jurisdiction of Waikhong PS), a combined team of CDO Unit Kakching and a team of Waikgong PS led by Inspt. Md. Jakaur Rahaman, OC/Waikhong PS under the command of Subedar Soraisham Birla Singh, OC CDO KCG, assisted by a platoon of A-Coy 126 BSF Bn led by SI Deep Kumar and a column of 46 Assam Rifles led by Maj Shivam Sachan, conducted CASO (cordon and search operation) at Ching Lukok near IVR road. The operation was started by 05:30 am and concluded by 07:30 am. After an intense search operation in the area, the following war like stores were recovered which were cached in the Jungle area of Ching Lukok.
