As we found the information, we have sent a Legal Notice to the Proprietor of the said company on 9<sup>th</sup> July,2024 through our Legal Counsel by Speed post. The company has been collecting, Packaging and trading in the local, national and International Market since last some months illegally.

So, you are requested kindly to initiate legal action against the company under section 314, ( dishonest misappropriation of property), 316( Criminal breach trust),318 (cheating) and other sections of Bharatiya Nyaya Sanhita ,2023 and U/S. 22 of GI Act,1999 and other relevant sections of this Act.
