Due to the current violence in the state we have left our resident bare-hand to save our lives on 04/05/2023, however I have learned that on the 1st week of June, 2024 an unidentified meitei mob have ransacked and looted our whole properties worth Rs.2511500/- (Twenty Five Lakh Eleven Thousand Five Hundred Only). However, the exact time and date could not be ascertained and in the mean time I was not in position to lodge the FIR as I was out of the state on personal work.

In this regards, I earnestly request your good office to kindly lodge an F.I.R against my lost/looted properties and initiate necessary action as per the law of the land. I further, request you to provide me a attested copy of my registered F.I.R.




