I have the honour to report you that on 26/08/2024 at about 1.00 P.M. some unknown persons of Phaitol Village had catching all the fishes in our 3(three) fisheries ponds by removing/hollowing the earth of the ring wall of the fisheries and deserted all the waters in the ponds which I have fallen fishes of 5000 Kgs. in the 3 (three) fisheries in the year 2018 and cause to loss about Rs. 18 lakhs. Further they also cut the Rubber trees about 40 trees and also removed the cover of the rubber trees in my farm which causes lost about Rs.12 lakhs. They also stolen following items i.e., (1) 2 (two) water pumps of Neptun brand cost of Rs. 36,000/-, (2) 4 (four) coil of 6" Plastic pipe of Rs. 48,000/-, (3) 1892 Kg. of Iron Pipe for making of farm house amounting Rs.1, 38, 000/-, (4) 1 (one) coil of electric wire of Rs. 4,000/-, (5) 3 (three) bundles of 100 meter Net of Rs.18, 600/- and (6) Household items about Rs. 3,000/- which are kept in the farm house by breaking the lock and key of my farm house located at Jairolpokpi Village, Jiribam near 87th B.N. of C.R.P.F Camp, Jairolpokpi, Jiribam.
